# 1:40 Extension work in water resources, Christine Hatch – Extension Professor (Geosciences)

• RiverSmart Communities – Extension funded project for ecologically restorative flood prevention and remediation (<u>http://extension.umass.edu/riversmart</u>)

Davidian - Concern expressed for the impact of new regulations on property owners, farmers, etc...

Bacon – Current regulations are based on a water quality concerns. This is an opportunity for existing regulations to be integrated with activities, data and policies that consider fluvial morphology and public safety.

# 2:10 Update on the Center for Urban Sustainability in Waltham Schrader)

- Current Waltham facility is "worn out"
- UMass Amherst is looking at options for redevelopment
- Consulting firm retained to study different possible design concepts

- Public funding has not yet been secured Chancellor and Dean Goodwin will be leading advocacy efforts

### 2:40 Update on the Mass. Food System Plan development process (Shoenfeld)

- Plan is nearly ready for publication and dissemination
  - Plan identifies significant need for Extension related functions (training, education and applied research) in many different areas

Shoenfeld - Request the Board's assistance in reviewing and supporting the plan

Lee – There is too much in the plan; it needs to be pared down

Shoenfeld – Agreed it is too big and advocated (unsuccessfully) for a more simple and more tightly focused plan

Bacon – Suggested that a more streamlined approach to education and training is needed: a "front door model" or "doc in the box"

### **3:10** Update on the 4-H Youth Development Program (Horn)

- Summer of Science program Food Science, Movie making, 3-D Printing
- 2,600 youth in traditional (club) programs
- 3,500 youth in camps
- 1,000 adult volunteers
- An additional 11,000 youth in specialized educational programs
- Statewide community service activities Food and family shelter assistance
- October 4th is national 4H kick-off
- Funding continues to be through grants, user fees and 4H Foundation

Bourgeois – Identified need for new opportunities for 4-H Youth in gardening education

Lee – Enquired about the status of 4-H membership?

Horn – Membership appears to be slowly increasing, particularly in Urban Areas.

King – Enquired about the nature of the new 4-H foundation marketing effort?

Horn – New banners and signs for visibility and recognition have been created. Most have been distributed to the counties

Lee – The last 4-H Foundation meeting gave a sense that membership was declining.

Davidian - Suggested outreach and partnership to farmers to allow 4H youth to use their farmland
